



PHII AND PHEII MARINE TOILETS

INSTALLATION AND MAINTENANCE INSTRUCTIONS

THE FOLLOWING ARE CAUTIONARY STATEMENTS THAT MUST BE READ AND FOLLOWED DURING BOTH INSTALLATION AND OPERATION

WARNING:  *Raritan Engineering Company, Inc. recommends that a qualified person or electrician in the case of PHEII, install this product. Equipment damage, injury to personnel or death could result from improper installation. Raritan Engineering Company, Inc. accepts no responsibility or liability for damage to equipment, or injury or death to personnel, that may result from improper installation or operation of this product.*

WARNING:  **Hazard of Flooding** - Any installation made below the waterline must have vented loops positioned properly and all hose connections should be double-clamped. Both intake and discharge seacocks should always be in the closed position when the toilet is not in use. Failure to do so may result in flooding, property damage and loss of life.

WARNING:  **Hazard of Fire** - Do not wire 120V PHEII motors without using specified rectifier. Do not operate PHEII series toilets with handle in place, serious bodily injury may occur.

INTRODUCTION

The PHII is a manual marine toilet. The PHEII has either electric push button or manual operation. Both toilets have the same overall dimensions. An electric drive (#PHECKII) that mounts between the bowl and pump converts a PHII to a PHEII with no additional floor space required.

The PHII and PHEII are available with a Household-style bowl and seat or with the Marine-size bowl and seat.

Space requirements for each are as follows:

All models are suitable for use in conjunction with Raritan's Lectra/San MC®, a Coast Guard Certified Type I flow-thru Marine Sanitation Device (MSD) and/or holding tanks.

OPERATION

WARNING: DO NOT adjust valve handle (1209BW) while toilet is operating; bodily injury may occur.

The intake valve handle (#1209BW) must be in the open or "FLUSH" (counterclockwise) position to draw water in. When the valve handle is in the "DRY" position a special air valve allows the toilet to be pumped dry without pressure build up. In the "DRY" position, toilet will only pump out; no water will be brought into the bowl.

It is advisable to flush the toilet briefly before use to minimize staining. Pumping several strokes after the bowl has been flushed will help to clear the lines, minimize odor and reduce the possibility of backflow into the bowl. It may be necessary to change the valve handle from "FLUSH" to "DRY" more than once to properly evacuate the bowl.

Valve handle must be *fully* in the "FLUSH" or "DRY" position only.

Hard objects or stringy substances (paper towels, feminine hygiene products, filter cigarettes, etc.) *must not* be thrown into the toilet as they will cause damage.

RETURNING PHEII TO MANUAL OPERATION

WARNING: Secure circuit breaker in "OFF" position before proceeding.

In the event of a power loss or problem with the electrical system:

1. Remove arm bolt and nut (#1115 and #1115A) from the connecting rod (#1116BW).
2. Displace connecting rod (#1116BW) from track and push toward the back.
3. Insert the handle (#1206W) and cotter pin (#1210A). Be sure the handle is completely in the handle socket and secured by the cotter pin to avoid the possibility of breaking the plastic socket (#1210).

To return to electrical operation, reverse procedure.

MAINTENANCE

Using C.P. (#1PCP22) a bio-enzymatic toilet bowl cleaner (available from Raritan Engineering), will keep the bowl clean and fresh smelling. Introducing Raritan Concentrate into flush water through a Toilet Water Kit (#TWK) will deodorize and lubricate the unit.

Super Lube® (#SL) applied to the piston rod will prolong the life of the Piston Shaft Seal. This should be done every spring and fall or more regularly if the head is used frequently.

CAUTIONS: Using improper deodorants or cleaners can result in damage to rubber and plastic parts. DO NOT USE pine oil, formaldehyde, ammonia, ethyl acetate, phosphoric acid and concentrated chlorine bleach, petroleum or solvent based products.

PHEII units should have Super Lube® applied to the connecting rod (#1116B) slot where the roller oscillates and to the track on the side of the pump housing where the connecting rod travels up and down.

Before attempting repairs, refer to the Troubleshooting section of this manual.

STORAGE

Short Term Storage

If the toilet is not going to be used for up to one week, flush the toilet several strokes with the shutoff handle in the *wet bowl* position to clear all lines.

Long Term Storage

If the toilet is not going to be used for over a week, follow the short term storage, then switch to the *dry bowl* position and purge the toilet with at least two gallons of fresh water added to the bowl.

WINTERIZING

Improper winter lay up is a major cause of marine toilet failures.

1. Close the intake and discharge seacock. Disconnect and drain the intake and discharge hoses. Winterize seacocks and hoses.
2. You will need two buckets, three feet (1M) of 3/4" (19mm) hose, three feet (1M) of 1 1/2" (38mm) hose and a quart (1 liter) of non-toxic antifreeze.
3. Prepare one half gallon (1.9 liters) of an antifreeze/water mixture in a bucket (refer to the antifreeze

instructions for antifreeze/water ratio). Place intake hose in this bucket. Place discharge hose into the empty bucket. Pump toilet until antifreeze has circulated and is being discharged.

4. Antifreeze should remain in the toilet until recommissioning. This will protect both intake and discharge sides of the pump. Pouring antifreeze into the bowl will only protect the discharge side of the pump, allowing the intake side to possibly freeze.

NOTE: Holding tanks, seacocks and treatment systems need to be independently winterized, stored and recommissioned (see manufacturer's instructions).

RECOMMISSIONING

1. Lubricate piston rod with Super Lube®.
2. Using the buckets, hoses and a gallon (3.8 liters) of clean water, flush the antifreeze out of the toilet. Dispose of antifreeze properly, in accordance with local and federal regulations.
3. Reconnect the hoses and open both seacocks.
4. Check all connections for leaks with several test flushes.

INSTALLATION OF REPLACEMENT PARTS

1. Refer to Fig. #2 when replacing part #1228CW.
2. If Valve Body (#1203BW) is removed it must be positioned as in Fig. #3 for proper operation.

Overhaul kits containing the parts normally required to repair each unit are available. In addition, individual parts for your toilet may be ordered through your dealer or direct from the factory.

INSTALLATION

To install PHII and PHEII marine toilets, several installation accessories are required:

1. A nominal 3/4" (19mm) thru-hull fitting and seacock (shutoff valve).
2. 3/4" (19mm) I.D. reinforced intake hose and stainless steel hose clamps.
3. 1 1/2" (38mm) I.D. reinforced sanitation discharge hose (Raritan #SH) and stainless steel hose clamps.
4. A nominal 1 1/2" (38mm) discharge thru-hull fitting with seacock may be required, depending on the specific installation.

5. PHEII units require wire, terminal ends, a momentary switch and a relay (#PBS and #CDS).
6. PHEII units that will be operated on 120 VAC shore or generator power require a full wave bridge rectifier in the circuit. Raritan #CH104 is a combination rectifier and activating switch.

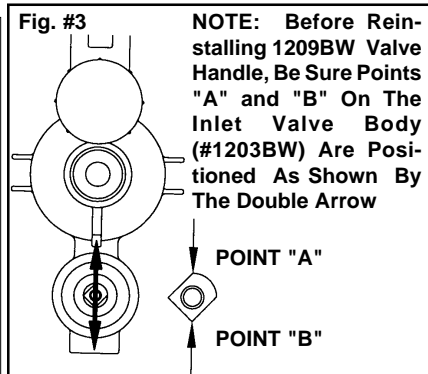
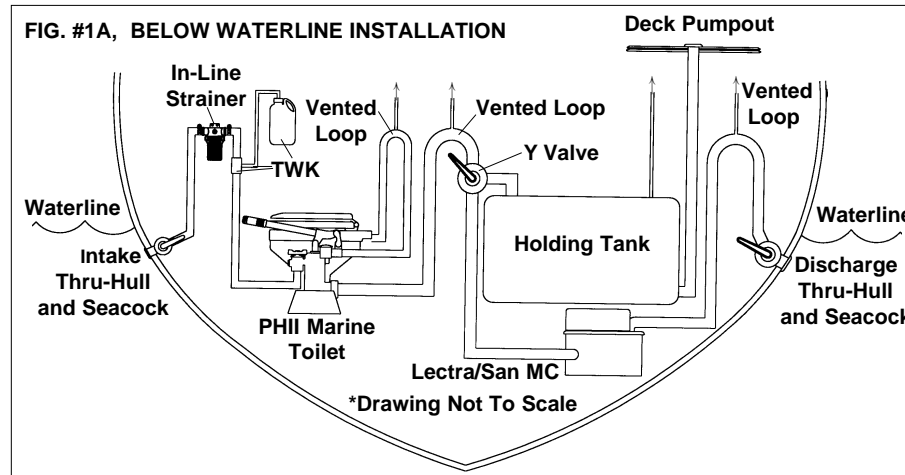
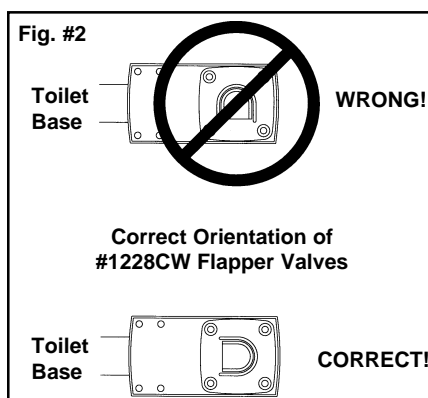
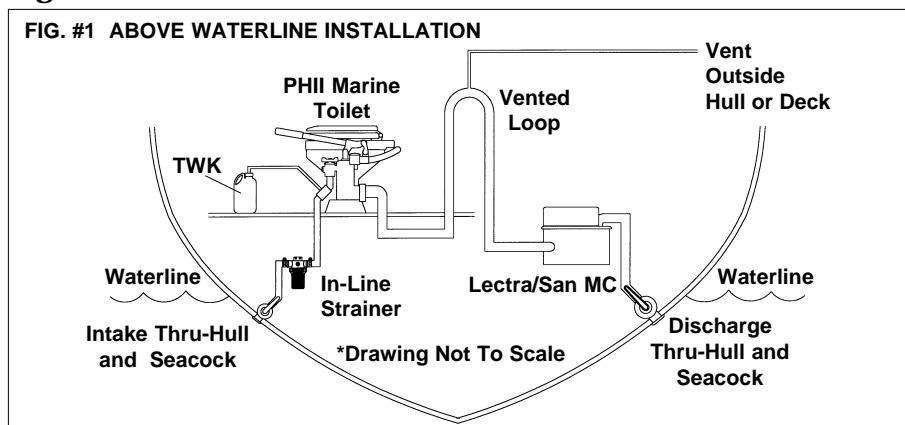
MOUNTING

PHII and PHEII may be mounted above or below the waterline (Figs #1 and 1A). Vented loops (#VL3/4 and #VL1 1/2) are required for below waterline installations and hose connections must be double clamped. Mount unit securely on a flat solid deck using stainless steel bolts backed up with nuts and large washers or stainless steel lag screws long enough not to pull out. **Never mount PHEII where it may be subject to shower spray or other sources of external water.**

PLUMBING

WARNING: Below waterline installations require vented loops. Top of the loop must be above waterline at greatest angle of heel. Intake vented loops must be installed between pump and back of the bowl. Discharge vented loops must be installed between the discharge of toilet and seacock. See Fig. #1 and #1A.

1. Route discharge hose above discharge outlet with a vented loop. This will enable the toilet to discharge more efficiently and will help to prevent backflow.
2. An In-Line Strainer (#163000) is recommended. This will help minimize odors and help prevent clogging.
3. Intake and discharge thru-hull fittings should be located far enough apart and in such a manner as to prevent discharge water from being drawn through the intake. One means of accomplishing this is to place them on opposite sides of the hull. Intake thru-hull should be located so that during shallow water conditions sand and other debris are not drawn into thru-hull fitting.
4. The optional Raritan Toilet Water Kit (#TWK) permits use of Raritan Concentrate (#CON22) with the PHII and PHEII toilets. Raritan Concentrate deodorizes the bowl and lubricates internal parts.
5. Test flush and check for leaks.



ELECTRIC CONVERSION KIT INSTALLATION (PHECKII) - For PHII Models Only

NOTE: It is recommended that the toilet be removed before installing the PHECKII.

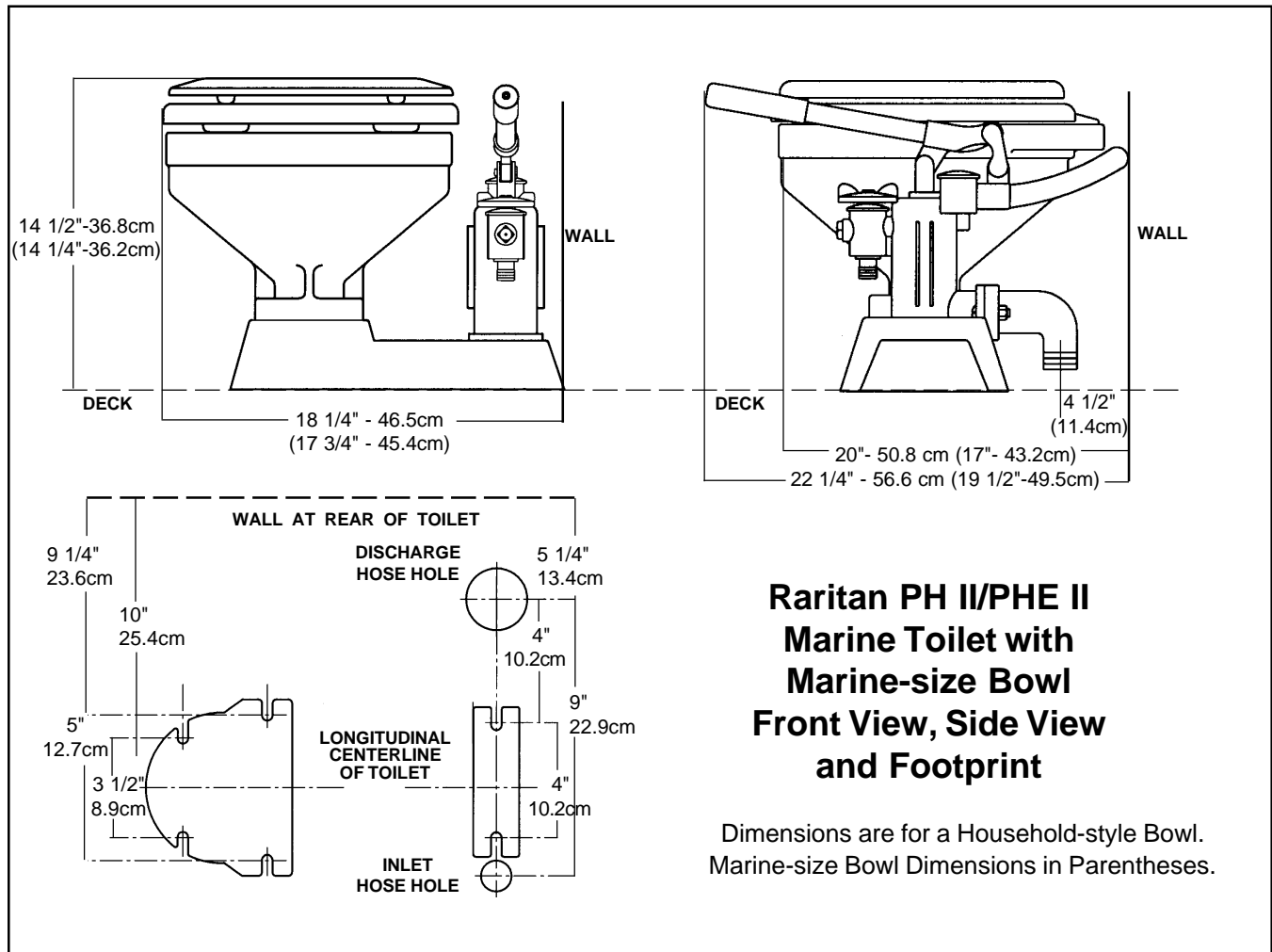
1. Close the seacocks.
2. Remove cotter pin (#1210A) and handle (#1206W) from toilet. Disconnect hoses and unbolt toilet from deck.
3. Align connecting rod in track on side of pump housing and place motor-gearbox unit in position on base (#1248W) between pump and bowl.
4. Insert four hex head screws (#1119A) with lock washers (#1118). Tighten evenly.
5. Insert bolt (#1115) through connecting rod (#1116B) and thread into yoke (#1211PL). Tighten jam nut (#1115A) securely; this connection is not a pivot point.

WIRING THE PHEII

WARNING: DO NOT wire a 120V PHEII motor directly to 120VAC service unless a rectifier has been added to the circuit; motor burnout, short circuiting and fire could result.

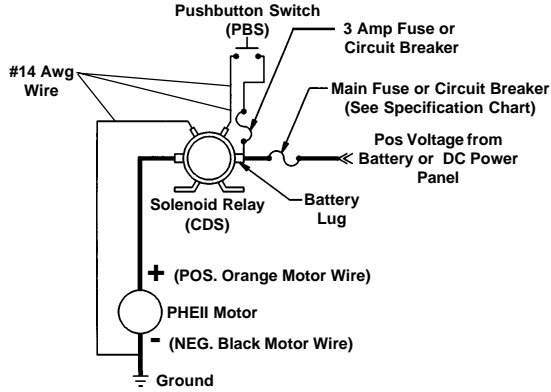
Refer to Fig. #5 to determine correct wire and circuit breaker sizes. Locate fuses and circuit breakers for easy accessibility and on a circuit separate from other accessories. 12, 24 and 32 VDC units require a momentary switch and a heavy duty relay rated for continuous service. See Fig. #4 for wiring diagram. The momentary Push Button Switch (#PBS) and Continuous Duty Solenoid (#CDS) are available through Raritan.

All PHEII120 models and PHECKII120 conversion kits are supplied for DC operation. 120V DC units require a double-pole momentary switch rated for 10 amps inductive load (#CHDPS120). For AC operation, a full-wave bridge rectifier is required (#CH104) includes rectifier and one double pole switch).

TROUBLESHOOTING

PROBLEM	POSSIBLE CAUSE	CORRECTION
A. Electric motor labors (pumps slowly) or handle is hard to pump on manual toilet.	A1. Low Voltage at motor while running A2. Air pocket in discharge line A3. Holding Tank vent clogged or tank full A4. Discharge line obstructed A5. MSD clogged A6. Discharge seacock closed.	A1. Check condition of batteries, terminals and wire connections for corrosion. Check gauge of wire to be sure it is not undersized. A2. Clean vent fittings. A3. Clean holding tank vent or empty tank as needed. A4. Check thru-hull fitting for clog. Remove discharge hose if necessary to free obstruction. A5. See MSD instruction manual. A6. Open discharge seacock.
B. Leak around piston shaft	B1. Cartridge seal worn. B2. Piston shaft scored.	B1. Replace piston shaft seal cartridge assembly. B2. Replace piston/rod assembly.

Scored pump housing or worn piston "O" ring F6. Worn housing or seal cartridge is drawing air	F1. See Fig. 3. F2. Clean as needed. F3. Clean line or strainer. F4. Remove check balls and clean. F5. Replace housing or "O" ring as necessary. F6. Replace housing or cartridge.

Units requiring extensive repairs may be returned to the Millville, NJ or Fort Lauderdale, FL office for overhaul. Instructions, including name, address and phone number MUST accompany returned units to ensure proper handling.

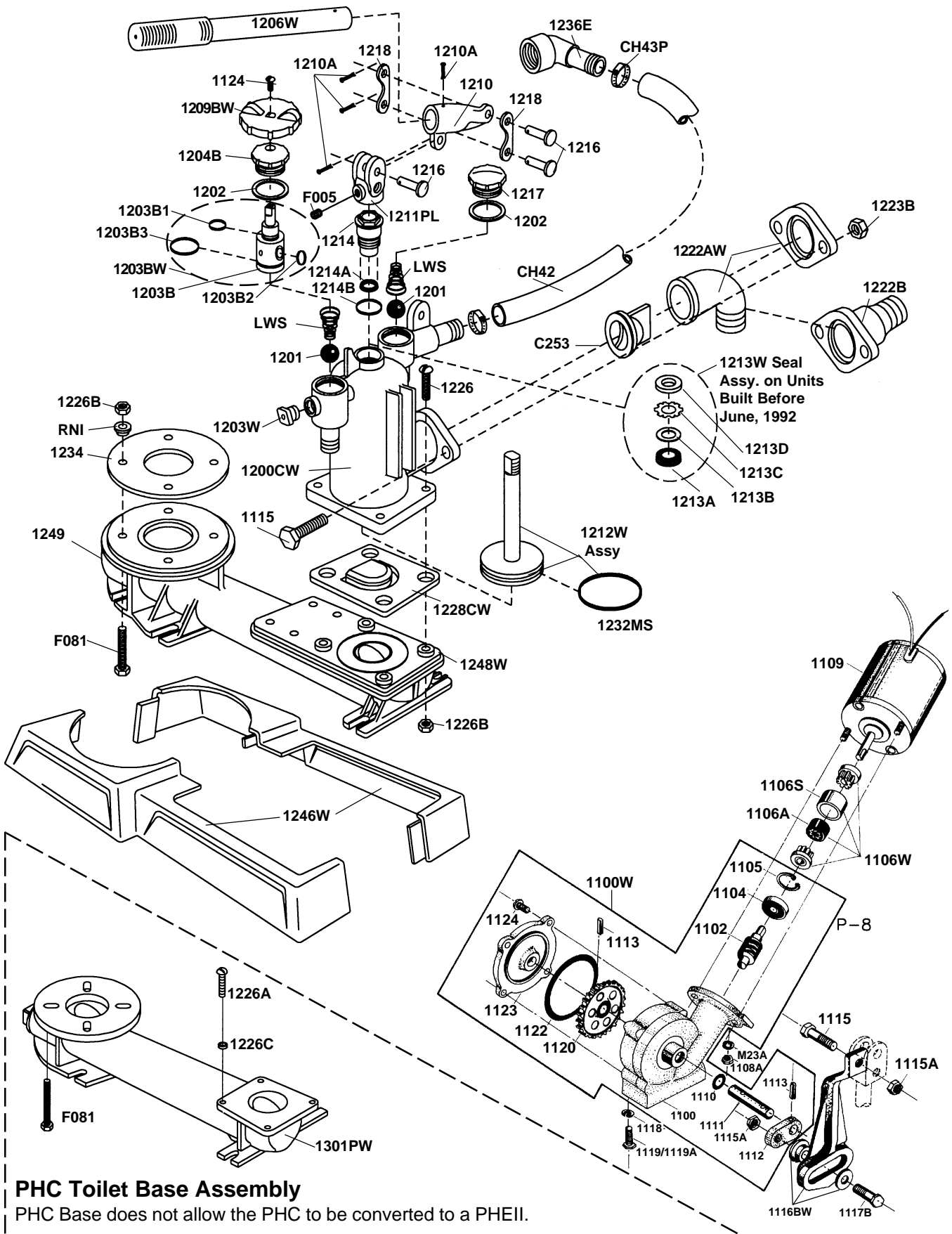
