**HAZARD OF FLOODING.** Failure to observe cautions below could result in flooding, property damage or loss of life. Failure of the Raw Water Strainer, after installation below the waterline, can result in sinking of your vessel.

- 1. Any installation made below the waterline must have hoses connected properly and connections double clamped; and be tested and responsibly maintained to protect the installation.
- 2. Always be sure both inlet and outlet seacocks or valves are in the closed position when the strainer will not be in use or when leaving the boat unattended.
- 3. Use only PVC fittings. Never install the Raw Water Strainer using metal adapters. The different expansion rates of metal and plastic can result in leakage or cracks.
- 4. Use only PTFE tape or paste on PVC fittings; never install using any other sealants or lubricants.


The Raritan Raw Water Strainer (RWS) can be used to protect engines, generators, air conditioning systems and other water cooled equipment from damage due to debris entering and clogging water passages. The RWS has a high capacity clear plastic body that lets you see trash accumulation, water condition and circulation. A large strainer basket catches and holds trash, debris, grass and other material that may be drawn into the intake lines. A mounting bracket facilitates mounting.

For boats with several different applications it is useful to have more than one strainer.

The intake and discharge plumbing connections accept PVC 1 1/2" MNPT adapter fittings.

### **INSTALLATION - MOUNTING**

- 1. The RWS should be installed where it can be secured to a bulkhead or other solid area. Locate the RWS above the waterline, when possible.
- 2. Mount with cap upright using the mounting bracket. Secure with stainless steel bolts, washers and nuts or stainless steel wood screws.



NOTE: Units manufactured before May, 1992 use a different Body (RWS1) and Cap (RWS2) which are not interchangeable with RWS6 and 7. If replacing the CAP(RWS1) or Body (RWS2) purchase RWS6W.

Maximum working pressure: 5 psi (34.5 kPa)

**Dimensions:** 9 3/4" (24.8cm) high and mounting bracket to discharge fitting 7 1/4" (18.4cm) wide

### **PLUMBING**

CAUTION: Plumbing connections can not be used to support the RWS. Install all hoses to RWS before mounting to prevent damage to mounting bracket. Close seacocks before installing strainer. DO NOT OVERTIGHTEN the adapters; tighten only enough to prevent leakage. Certain joint compounds will cause deterioration of the plastic material resulting in cracks around the threaded areas. Never use metal adapters as the different rates of expansion may cause leakage or cracking of the plastic case.

- 1. Arrows indicate direction of flow in and out of strainer.
- 2. Do not use PTFE tape on cap threads; use only Superlube (SL) to lubricate cap threads.
- 3. Use PTFE tape or paste on threads of fittings and adapters. Secure proper size adapters onto intake and discharge fittings.

- 4. Connect hoses to the adapters using two stainless steel hose clamps per connection.
- Tighten cap onto strainer body. A positive stop prevents overtightening. DO NOT TIGHTEN PAST STOPS.
- 5. Once installed, open seacocks and check strainer installation for leaks. Turn on the equipment the strainer is protecting. Check the flow and check for leakage at the fittings. If leakage occurs shut off the equipment and recheck the installation.

### **MAINTENANCE**

Periodically check strainer for debris. Check all connections for leaks. Strainer basket can be removed for easy cleaning.

### WINTERIZATION

Close seacocks, drain the strainer completely. Do not add anti-freeze compounds, they will cause deterioration of the plastic, causing it to crack.

### LIMITED WARRANTY

Raritan Engineering Company warrants to the original purchaser that this product is free of defects in materials or workmanship for a period of one year from the product's date of purchase. Should this product prove defective by reason of improper workmanship and/or materials within the warranty period, Raritan shall, at its sole option, repair or replace the product.
